**ARTICLES OF INCORPORATION
OF
IDAHO IRRIGATION EQUIPMENT ASSOCIATION, INC.**

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, all being citizens of the United States, of legal age, this day having voluntarily associated ourselves together for the purpose of forming a non-profit corporation under and pursuant to the provisions of Chapter 10, Title 30, Idaho Code, do hereby certify:

ARTICLE I.

Name

The name of the corporation shall be "IDAHO IRRIGATION EQUIPMENT ASSOCIATION, INC."

ARTICLE II.

Location

The location of the principal office of the Association shall be any place designated by the Board of Directors. The registered office of the Association shall be Boise, Ada County, Idaho, and its term of existence shall be perpetual.

ARTICLE III.

Purposes

The purposes and objectives of the Idaho Irrigation Equipment Association shall be purely benevolent and educational and shall not be for pecuniary gain or profit. No part of the net earnings of the organization shall inure to the benefit of or be distributed to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered. Notwithstanding any other provision in these Articles, the organization shall not carry on any other activities not permitted by an organization exempt from federal income tax under Section 501 (c) (6) of the Internal Revenue Code of 1954 (or the corresponding provisions of any other future United States Internal Revenue law). These purposes and objectives are as follows:

- a) To promote the development, proper use and acceptance of irrigation equipment for all possible applications.
- b) To promote water and soil conservation, quality of environment, and more economical crop production through the use of irrigation.
- c) To collect and disseminate information regarding irrigation of value to members of the association, to allied industries and to the public.
- d) To acquaint public and private agencies, institutions and organizations with developments in the industry and the part of the industry occupies in the economy and development of the State of Idaho.

- e) To promote a spirit of cooperation among the members of the industry.
- f) To secure cooperative action in advancing the common purposes of its members, foster equity in business usages, and promote activities aimed to enable the industry to conduct itself with the greatest economy and efficiency.
- g) To give proper consideration and expression of opinion upon questions affecting the industry and the financial, commercial and industrial interest of the State of Idaho.
- h) To cooperate with other state and national groups and with non-retail groups, such as educational organizations, farm organizations, chambers of commerce, on matters of common interest that affect the irrigation industry; and on programs that strengthen and develop the state's agricultural and industrial economy.

ARTICLE IV.

Membership

The association shall be conducted as a non-profit, cooperative association, without capital stock, sustained by the payment of each member of an annual membership fee, which shall be fixed as directed by the By-Laws and as nearly as practicable at the cost of services rendered or made available to members.

Any person, firm, corporation or association, possessing such qualifications as may be prescribed by the By-Laws, may become a member upon admission by the Board of Directors. The rights and interests of all members shall be equal. A membership may be transferred or assigned only to a qualified person (other than a member) upon consent by resolution of the Board of Directors and under such regulations as may be prescribed by the By-Laws.

BY-LAWS

ARTICLE I

The name of this Association shall be "Idaho Irrigation Equipment Association, Inc."

ARTICLE II

Principal Place of Business

The principal office of the Association shall be located in a city where the directors deem advisable.

ARTICLE III

Objects and Purposes

Section 1. The objects of this Association shall be set forth in the Articles of Incorporation.

Section 2. This Association is a non-profit organization and no part of the dues, fees, assessments or other monies collected by the Association shall enure to the benefits of any member of the Association and upon dissolution, any unexpended funds on hand shall be returned to the members in the proportion contributed by the, but not in excess of the amount contributed by any such member during the last year of the existence of the Association, and the balance, if any, shall be distributed to such charitable organizations as may be selected by the Board of Directors.

ARTICLE IV

Membership and Voting Rights

Irrigation equipment is defined as all the equipment supporting directly surface or sprinkler irrigation methods from water supply development, and preparation equipment to water handling equipment. A non-voting, non-office holding membership shall be available to any person, firm or corporation not directly nor indirectly connected with any manufacturing of or selling of irrigation equipment, as defined above, who shall be deemed a technical or supporting member with their profession or occupation connected with the supporting phases of irrigation.

Section 2. Voting Rights. Active membership in the Association shall be entitled to one vote in all general meetings of the members. A member company represented by more than one individual shall have only a single vote.

Section 3. Application for Membership. Application for any membership shall be in writing on forms provided by the Secretary of the Association, and upon a majority vote of the Board of Directors. The applicant shall be eligible for membership upon payment of dues as hereinafter provided.

ARTICLE V

Section 1. Membership dues shall be assessed annually for active, technical or supporting firm or corporation. These amounts are set by the Board of Directors and are subject to change.

Section 2. There shall be no special assessments or any other type of assessments whatsoever levied.

Section 3. Dues are payable on or before February 10 of each year. In the event the dues of a member are not paid before the expiration of sixty (60) days after the due date, such member shall be deemed delinquent and shall be notified by the Secretary to that effect. If after such notice a member shall neglect or refuse to pay within thirty (30) days from date thereof, such omission shall constitute a suspension of all rights and privileges of the membership and such member shall be dropped from the membership of the Association and the member so notified.

ARTICLE VI

Officers, Their Powers and Duties

Section 1. The Officers of this Association shall be a President, Vice President, and a Treasurer, and shall be elected for a term of one year.

Section 2. The President shall preside at all meetings of the Association, meetings of the Board of Directors and as executive head of the Association he shall enforce the law and execute the orders of the Association and of the Board of Directors. He shall appoint, subject to the approval of the Board of Directors, all committees or offices in which any vacancy occurs. No person shall serve as President for more than two consecutive terms. The President, as presiding officer of all meetings, shall not be entitled to vote unless a tie vote exists at which time the President would then be entitled to cast the tie-breaking vote.

Section 3. The Vice-President, during the absence or disability of the President shall exercise all the powers and discharge all of the duties of the President until the President shall return or his successor be chosen by the Board of Directors, and perform such other duties as may be assigned by the Board of Directors. No person shall serve as Vice President for more than two consecutive terms.

Section 4. The Treasurer shall have general supervision over the finances of the Association. The Treasurer shall have access to all monies and securities belonging to the Association under the direction of the Board of Directors. The Treasurer shall be authorized to sign checks against funds on deposit of the Association for expenditures authorized and approved by the Board of Directors provided that such checks shall be countersigned by any one of the following: The President, Vice-President, or Secretary. The Treasurer shall have duplicate keys to any safe deposit box where the Association's securities are kept. The Treasurer shall make a report to the Board of Directors at every board meeting and perform such other duties relating to the Association's finances as may be directed by the President or Board of Directors. At the direction of the Board, the Treasurer shall appoint Finance and Audit Committees to help make financial decisions. All financial decisions shall be ratified by the Board of Directors.

Section 5. Any officer may be removed from office for neglect, or refusal to perform his/her duties or misconduct, by a three-fourths vote of the Directors present at a regular meeting, or at a special meeting called for the purpose provided that the notice thereof shall have been given in writing to the accused at least thirty (30) days prior to said meeting.

Section 6. In case of the absence or disability of any officer or Director, the position may be filled pre tempore by an appointment of the President.

Section 7. Officers elected shall hold office for one year, or until successors qualify. Officers and new members of the Board of Directors shall take office at the conclusion of the annual membership meeting.

ARTICLE VII

Executive Committee

Section 1. Composition. There shall be an Executive Committee, which shall consist of the elected officers of the Association, namely the President, the Vice-President and the Treasurer, plus the Immediate Past President.

Section 2. Authority. During the interim between regular or special meetings of the Board of Directors, the Executive Committee shall be delegated all the powers of the Board, as defined in Article VIII of the By-Laws.

ARTICLE VIII

Board of Directors

Section 1.

- (a) There shall be a Board of Directors composed of six active members of the Association, one of whom may be a technical member of the Association. In addition the President, Vice-President and Treasurer of the Association shall be members of the Board of Directors for the term of their office with the same privileges as elected members of the Board. The President shall be Chairman of the Board. Directors elected at the annual meeting, unless removed for cause, shall serve for two years. The Directors (other than the officers) shall
-

be nominated and elected in accordance with Article XII of these By-Laws. Upon the election of the first six members of the Board of Directors, a drawing shall be held which drawing will designate which three of the six elected Directors shall serve a term of one year and which three shall serve a term of two years. Thereafter, three Directors will be elected each year and serve two years.

- (b) Past President as Ex-Officio Member of the Board of Directors. The immediate Past President of the Association currently employed by an Active member of the Association or devoting a substantial part of his time to either the manufacture or distribution of irrigation equipment shall be an ex-officio member of the Board of Directors. As an ex-officio member he/she shall be entitled, if he/she so desires, to attend all meetings of the Board of Directors. The Past President shall have privileges on the floor in discussions of any subject being considered by the Board but may not offer or second motions or vote on pending questions. Notices of meetings of the Board of Directors, copies of the budget and financial reports, and minutes of all Board Proceedings shall be mailed to the Past President at the same time they are mailed to other members of the Board of Directors. All Past Presidents may attend meetings of the Board of Directors without vote or ability to make a motion or second a motion.
- (c) Advisory Board. There may be an Advisory Board composed of three technical or supporting members of the Association. The Board of Directors shall appoint the members of this board. No Advisory Board member shall serve for more than two consecutive years. The Board of Directors shall be authorized to request the aid and support of this Board for any purpose for the benefits of this Association to the extent as stated in Section 2 (F) of this Article.

Section 2.

- (a) The Board of Directors shall constitute the governing body of the Association. It shall be vested with full power and authority to put into effect the laws, resolutions and decisions of the Association and by a two-thirds vote of the Directors present at any meeting, to make, alter, or amend rules and regulations not in conflict with the Certificate of Incorporation, for its own government and that of the Association. It shall have authority to approve appointments made by the President for all offices in which there may be made vacancies: to exercise general supervision over the receipts and expenditures of the Association; to appoint or authorize the employment of employees and other agents of the Association and to define the duties of its officers, other than as defined herein: to fix the compensation of any employees and officers of the Association, and to do all other acts and things which it may deem to be of interest to the Association.
 - (b) The Board of Directors shall hold its first regular meeting during the annual Winter Show of the Association each year. The Board may hold such other regular and special meetings as it may deem necessary. Five members of the Board of Directors shall constitute a quorum for the transaction of business of any of its meetings, except as otherwise provided.
 - (c) The Board of Directors may, at its discretion, submit to the members of the Association by letter-ballot, any question relating to the affairs of the Association. Not less than thirty (30) days shall elapse between the mailing to such letter-ballot and the closing to the poll thereon. The question submitted shall be stated in a form approved by the Board of Directors and accompanied by a brief summary of the arguments for and against the proposal. The ballots cast shall be counted by tellers appointed by the President. A majority of the votes cast shall be regarded as binding instructions to the officers of the Association, provided that not less than fifty-one percent (51%) of the qualified members of the Association participate in the vote. Provided, further, that nothing in this section shall be construed to prevent the commitment of the Association upon matters of public policy by a majority vote of the members present at any annual or special meeting of the Association.
 - (d) The Secretary of the Association shall be appointed by the Board of Directors and may be a member of the Association but such membership will not be mandatory. The duties of the Secretary shall be to record the minutes of all meetings of the Association and its Board of Directors. In addition thereto, the Secretary shall supervise the clerical duties of the Association office, including all mailings and other such duties normally associated with the position of Secretary. He/She shall be without vote and without the privilege of making or seconding any motion before any meeting whether it be annual, special, or meeting of the Board of Directors. The Secretary's compensation, if any, shall be set by the Board of Directors. The Secretary shall handle the funds for the association and shall process and deposit all checks, pay bills, and prepare financial information for outside accountants at tax time. The Secretary shall present financial reports monthly to the Treasurer and quarterly to the Board of Directors. The Secretary may be a contract employee and be responsible for paying
-

all state and federal taxes. The Secretary shall be bonded. A premium for such bond shall be paid by the Association.

- (e) The Board of Directors shall annually cause the books and the accounts of the Association to be audited by the Audit Committee and said committee shall submit its report to the membership at the annual meeting.
- (f) It shall be the duty and the responsibility of the Board of Directors to limit the activities of the Association and of its officers to the purpose authorized in the Articles of Incorporation and By-Laws and to cause such of these activities and functions as the Association undertakes to be carried out in an appropriate and lawful manner.

ARTICLE IX

Standing Committee

Section 1. The President shall appoint, with the approval of the Board of Directors, chairpersons for the following committees as the Board sees fit: Membership, Audit, Finance, Educational, Idaho Irrigation Equipment Show also known as "the Winter Show", Summer Meeting, Scholarship, and Constitution and By-Laws.

The duties of the Committees shall be as follows:

Membership Committee: This Committee shall consist of active members appointed by the Chairperson.

Audit Committee: This Committee shall consist of active members appointed by the Chairperson.

Finance Committee: This Committee shall consist of active members appointed by the Chairperson.

Idaho Irrigation Equipment Show Committee: This committee shall have a representative from the University of Idaho Irrigation Extension Service. There may be a Chair representing the Agricultural interests of the Association and a Chair representing the Turf interests of the Association. Also, a person may be appointed as a Chair to plan the training for the Members. The Chairs shall work in association with the Secretary in planning, marketing, and executing the Show sponsored by the Association. The Board of Directors shall approve all appointments by the president.

Summer Meeting Program Committee: This committee shall consist of active members appointed by the Chairperson.

Constitution and By-Laws Committee: This Committee shall consist of active members appointed by the Chairperson.

Educational Committee: The Chairman of this Committee shall be the representative of the University of Idaho Irrigation Extension Service, with committee members appointed and approved by the President and Board of Directors.

Scholarship Committee: The Chairman will appoint a grading committee to review and score the scholarship applications. The Chairman will work with the Secretary in acquiring funds for the program and distributing the funds to the universities.

Article X

Section 1. An Annual Meeting of the members of the Association shall be held during the first quarter of each year, during the Irrigation Equipment Show, at such time as the Board of Directors shall determine.

Section 2.

- (a) General meetings of the members of the Association may be called by the President or by order of the Board of Directors at any time, either at the principal office of the Association or elsewhere, and notice of such meetings shall be mailed by the Secretary to each member at least thirty (30) days before such meeting. It shall be the duty of the Board of Directors or the President to call a special meeting of the members upon written request by twenty-five percent (25 %) of the members of the Association.
 - (b) Attendance at any annual or special meeting is limited to members, applicants for membership and guests invited on authorization of the Board of Directors.
-

Section 3. Any member entitled to vote may be represented at any meeting by a properly authorized proxy. Such proxy shall be a member of the Association or directly associated with the firm, partnership or corporation he/she represents. A quorum at all meetings shall be a majority of the Board of Directors and all members present, provided the membership has been duly notified as stated in Section 1 and Section 2 of this Article.

Section 4. The Secretary shall send out a blank form of proxy to every member entitled to vote. Proxies to be recognized must be delivered to the Secretary prior to the opening of the meeting at which they are to be voted. Except as otherwise provided by law or in these By-Laws, action by members entitled to vote at the Association in meeting duly assembled, shall be affirmative vote of a majority of members present in person or by proxy.

Article XI

Order of Business

Section 1: At all meetings of members of the Association, the presiding Officer or Chairperson shall determine the order of business to be followed at the meeting.

Section 2: Motions: When motions are made at any IIEA meeting, the following steps will be used:

STEP 1: A member is recognized and makes a motion;

STEP 2. Another member seconds the motion;

STEP 3. The presiding officer restates the motion to the assembly;

STEP 4. The members debate the motion;

STEP 5. Presiding officer asks for the affirmative votes and then the negatives votes;

STEP 6. The presiding officer announces the result of the voting; instructs the corresponding officer to take action; and introduces the next item of business.

Article XII

Nomination and Elections

Section 1. Nomination of Officers and Board of Directors. The Board of Directors shall determine the candidates whom it intends to present to the membership for the respective offices of President, Vice President, Treasurer and Board Members. The slate of officers and Board Members for the next ensuing year shall be announced to the membership not later than thirty (30) days prior to the annual membership meeting. Candidates for the offices of President, Vice President, Treasurer and Board of Directors shall be active members of the Association.

Section 2. At the annual membership meeting, the Presiding Officer shall formally nominate the slate of officers for the offices of President, Vice President, Treasurer and Board of Directors. Any five (5) active members of the Association present at the meeting shall be entitled to nominate additional candidates from the floor for the offices of President, Vice President, Treasurer and Board of Directors. Candidates may be nominated on more than one slate.

Section 3. Election of Officers. Election shall be by a majority vote and if no candidate receives a majority on the first ballot taken, the two highest candidates shall be voted for on the next ballot. The Secretary shall be appointed by the newly elected Board of Directors.

Section 4. In the event of a vacancy caused by the failure of the Association to elect, or by the death or resignation or removal in the Board of Directors or officers, (other than the President), the vacancy shall be filled by the President with the approval of the Board of Directors. An officer so appointed shall continue in office until the next annual meeting or until his successor is duly elected and qualified. Any Director so appointed shall continue in office for the unexpired term or until his successor is elected and qualified. In case of the death, resignation or disqualification of the President, the Vice President shall fill the unexpired term.

Section 5. The Board of Directors shall have the power, by a two-thirds vote of its members, in meeting or otherwise, to cancel or postpone an annual meeting if it believes such action to be in the best interests of the organization. In the event of such cancellation or postponement: the Board shall be authorized to formulate rules for the election of officers by mail.

ARTICLE XIII

Section 1. The By-Laws of this Association may be altered, amended or repealed by a majority vote of the Active membership at any annual or special meeting of such membership, provided that written notice of the proposed alteration, amendment or repeal shall have been sent to the active membership with the call for such meeting at least thirty (30) days prior to the date of said meeting.

Section 2. Amendments may also be proposed at the annual meeting and after their consideration and unanimous approval by those present, such amendments may be acted upon without the thirty days notice provided in Section 1 of this Article.
